Roles & Responsibilities:

- Provide technical expertise to the Board of Directors in achieving the mission of the organization.
- Serve as advocates for the organization to various communities
- Provide feedback to the organization from the community
- Enhance the organization's public image.

Position Description:

- Attends all Advisory Board meetings
- Reports to the Board of Directors chair (president and or CEO)
- Makes a commitment to participate in SAMA work
- volunteers for and willingly accepts assignments and completes them thoroughly and on time
- Support the organization through attendance at special events and activities
- Makes a 1 year commitment and willingness to serve.

- Event management
- Mentorship of SAMA Staff, volunteers
- Fundraising

Requirements:

- Not a current SAMA BOD members or SAMA staff

Advisory Board - Roles and Responsibilities

Recruitment of new advisory board members

- 1. Nominations are reviewed in the scheduled monthly Board of Directors meeting
- 2. Once nomination is approved, the advisory board member is asked to complete the online form that includes attestation of abiding with the code of conduct and confidentiality policies
- 3. Once completed, the advisory board member is invited to the next advisory board meeting

Evaluation/Renewal

- 1. Starting October 2024, and every October thereafter, all advisory board members undergo self and peer evaluation, as part of the organization's annual performance review, on the basis of which they select one of the following options:
 - a. continue in advisory board
 - b. relief from advisory board duty
- 2. Those who request relief of duty, are then removed from the advisory board
- 3. If the advisory board member does not respond to the survey, then they are considered to not want to continue in the advisory board and are then removed.
