Objective

 - specific - subject matter expertise: nephrology, craniofacial surgery, operative nursing, etc.)

Recruitment of new advisory board members

1. The Executive Director nominates Advisory board candidates
2. Nominations are reviewed and approved by the Board of Directors in November of each year
3. Once the nomination is approved, the advisory board member is asked to complete the online form, which includes attestation of abiding with the code of conduct and confidentiality policies
4. Once completed, the advisory board member is invited to the next advisory board meeting in December

Advisory Board Evaluation/Renewal

Annual Evaluation: Starting October 2024, and every October thereafter, all advisory board members will undergo an evaluation process to determine their renewal status.

Renewal Decision: A committee, comprised of the Executive Director, President, and Secretary General, will evaluate the performance and contributions of advisory board members and make decisions regarding their renewal.

Options for Members:

- * Members recommended for renewal will be invited to continue on the advisory board.
- * Members not recommended for renewal will be relieved from advisory board duties.

Appeals Process: If any member of the advisory board members disagrees with the committee's decision to relieve from advisory board duty, then they can contact the SAMA president requesting continuation in the advisory board.
